Enact 35 mph on the following streets:

- (1) Cedar Valley Avenue (SR 1127) from US 321-A to the eastern corporate limit, approximately 1.04 miles east of US 321-A.
- (2) Cahaj Avenue (SR 1127) from US 321-A to a point 0.37 miles west of US 321A.
- (3) Legion Avenue (SR 1156) from US 321-A to SR 1158.
- (4) Caldwell Avenue (SR 1159) from US 321-A to the western corporate limit, approximately 50 feet east of SR 1158.
- (5) SR 1161 from US 321-A to Hilltop Street (SR 1161).
- (6) Mt. Herman Avenue (SR 1160) from US 321-A to the eastern corporate limit, approximately 0.43 miles east of US 321-A.
- (7) Main Street (US 321-A) from Cedar Valley Avenue (SR 1127) to a point 0.10 miles north of Caldwell Avenue (SR 1159).
